2. Mar 12, 1818 – James NASON, Yeoman of Gorham, owes \$4.82 to Levi HALL of Gorham. Date due-Nov 18, 1817.
3. Jun 24, 1819 – Jeremiah ABBOT, Yeoman of Falmouth, owes \$10.43 to John VARNEY, Yeoman of Windham.
4. Jun 28, 1819 – Samuel LEACH of Raymond owes Moses LITTLE Esqr. of Windham \$14.61. Date due-Oct 13, 1818.
5. Aug 2, 1819 – Francis MAYBERRY of Windham owes Moses LITTLE \$9.45. Due date-Nov 10, 1818.
6. Aug 17, 1819 – Abraham ANDERSON Jr., Yeoman of Windham, owes \$8.76 to Noah I. SENTER, Cooper of Potsdam, County of St. Lawrence, State of NY.
7. Jan 28, 1820 – James NASON, Gentleman of Gorham, owes \$13.92 to Moses LITTLE of Windham. Date due-Nov 25, 1819.
8. Mar 29, 1821 – James CRAGUE of Windham owes \$5.93 to Nehemiah WINSLOW, Trader of Windham. Date due-Jul 5, 1820. 2nd Exon issued Jun 13, 1821- notation shows 3rd Exon issued Aug 17, 1821
9. Apr 16, 1821 – Isaac KILBORN, Yeoman of Windham, owes \$18.78 to Moses LITTLE Esqr. of Windham.
10. Apr 28, 1821 – Nathaniel JORDAN Esqr. of Raymond, owes \$ \$12.26 to Isaac PHINNEY, Blacksmith of Gorham. 2nd Exon issued Aug 16, 1821. 3rd Exon issued Aug 10, 1822. 4th Exon issued Nov 15, 1822-notation shows 5th Exon issued Sep 13, 1823
11. May 27, 1821 – Elisha EMERY, Yeoman of Gorham, owes \$7.17 to Moses LITTLE Esqr. of Windham.
12. Jul 23, 1821 – Nathaniel SWETT, Yeoman of Raymond, owes \$18.12 to James LORD, Yeoman of Raymond. 2nd Exon issued Feb 2, 1822-notation shows 3rd Exon issued May 19, 1822.

13. Nov 3, 1822 – William GAMMON Jr., Yeoman of Otisfield, owes \$13.80 to Nathaniel Y. THOMPSON, Yeoman of Raymond. 2nd Exon issued Nov 15, 1822- notation shows 3rd Exon issued Jan 13, 1822 [sic].

14. Dec 25, 1822 – Elisha EMERY, Yeoman of Gorham owes \$8.28 to John VARNEY Jr., of Windham. Notation shows 2nd Exon issued Mar 27, 1823.

15. Mar 14, 1823 – Jonathan WIGHT, Yeoman of Baldwin, owes \$13.57 to Mark LEACH, Trader of Raymond. Notation shows 2nd Exon issued Jun 2, 1823.

16. Mar 25, 1823 – Benjamin WHITMAN, Blacksmith of Raymond owes \$7.98 to Enoch CHESLY, Yeoman of Windham. Notation shows 2nd Exon issued Jul 12, 1823.

17. Mar 25, 1823 – Joseph STAPLES Esqr. of Windham, owes \$4.70 to John VARNEY Jr., Gentleman of Windham. 2nd Exon issued Jul 26, 1823-notation shows 3rd Exon issued Sep 30, 1823.

18. Apr 6, 1823 – John A. KNIGHT, Yeoman of Windham, owes \$17.06 to Elizabeth HAWKS, Spinster of Windham. Notation shows 2nd Exon issued Apr 14, 1823.

19. May 26, 1823 – Daniel DAVIS, Yeoman of Raymond, owes \$7.19 to Harvey MAYBERRY, Yeoman of Otisfield. 2nd Exon issued Jul 11, 1823. 3rd Exon issued Sep 30, 1823-notation shows 4th Exon issued Dec 22, 1823.

20. Jun 1823 – John MAYBERRY, Yeoman of Windham owes \$12.09 to Ebenezer PROCTER, Trader of Windham. Notation shows partial payment & 2nd Exon issued Dec 22, 1823 for remainder of debt.

21. Aug 9, 1823 – James B. WALKER, Yeoman of Raymond, owes \$8.24 to Mark LEACH Jr., Trader of Raymond. 2nd Exon issued Aug 3, 1824-notation shows a 3rd Exon issued Aug 16, 1825. 4th Exon issued Dec 15, 1825-notation shows 5th Exon issued Feb 15, 1826 and partial payment made.

22. Aug 24, 1823 – Benjamin MAINS, Yeoman of a place called the Cape, owes \$8.05 to James FORD, Trader of Raymond. Notation shows 2nd Exon issued Oct 8, 1823.

23. Aug 24, 1823 – Enoch GAMMON, Yeoman of Otisfield, owes \$10.26 to James FORD, Trader of Raymond. Notation shows 2nd Exon issued Sep 13, 1823.

24. Aug 24, 1823 - John WHITMORE (possibly WHITMAN), Blacksmith of Standish, owes \$9.60 to Ebenezer PROCTER, Trader of Windham. Notation shows 2nd Exon issued Dec 22, 1823. 3rd Exon issued Mar 26, 1824. 4th Exon issued Aug 9, 1824-notation shows 5th Exon issued Sep 14, 1825

25. Aug 24, 1823 – Jacob ALLEN, Yeoman of Windham owes \$5.75 to John COLLINS, Yeoman of Windham. 2nd Exon issued Sep 11, 1823-notation shows 3rd Exon issued Dec 9, 1823. 4th Exon issued Mar 26, 1824. 5th Exon issued Aug 3, 1824-notation shows 6th Exon issued Jul 22, 1825.
26. Aug 24, 1823 – John LOMBARD, Yeoman of a place called the Cape, owes \$8.76 to Horatio N. PIERCE, Trader of Windham. 2nd Exon issued Sep 13, 1823. 3rd Exon issued Aug 3, 1824. 4th Exon issued Dec 8, 1824- notation shows 5th Exon issued Jun 8, 1825.
27. Aug 24, 1823 – Nathaniel KNIGHT, Yeoman of a place called the Cape, owes \$3.70 to Horatio N. PIERCE, Cordwainer of Windham. 2nd Exon issued Aug 3, 1824. 3rd Exon issued Jun 8, 1825- notation shows 4th Exon issued Aug 16, 1826.
28. Nov 25, 1823 – Thomas MANCHESTER, James McINTOSH and William FIELDS Jr., Yeomen of Windham, owe \$10.28 to Moses HARRIS, Gentleman of Gray.
29. Dec 10, 1823 – John LOMBARD, Laborer of Standish, owes \$7.57 to Jeremiah McLUCUS, Yeoman of a place called the Cape. Notation shows 2nd Exon issued Apr 13, 1824.
30. Dec 16, 1823 – Lot NASON, Yeoman of Standish, owes \$19.32 to John WHITE, Gentleman of Windham. 2nd Exon issued Apr 13, 1824.
31. Dec 23, 1823 – Samuel HAMBLIN, Yeoman of Bridgton, owes \$6.27 to Mark LEACH Jr., Trader of Raymond. 2nd Exon issued May 12, 1824. 3rd Exon issued Sep 15, 1825-notation shows a 4th Exon issued Dec 14, 1825.
32. Dec 23, 1823 – Isaac BARTLETT, Yeoman of Otisfield, owes \$4.72 to Joshua PERRY, Clothier of Raymond. 2nd Exon issued Apr 23, 1824-notation shows 3rd Exon issued Apr 1, 1825.
33. Dec 27, 1823 – Willoughby SCRIBNER, Yeoman of Harrison, owes \$8.39 to William JOHNSON and Nathaniel MOSHER 3rd, Yeomen of Gorham.
34. Mar 18, 1824 – Nathaniel JORDAN, Gentleman of Raymond, owes \$7.93 to Ebenezer PROCTER Jr., Trader of Windham-notation shows 2nd Exon issued Aug 16, 1825.
35. Apr 23, 1824 – Elijah HAMBLIN, Yeoman of a place called the Cape, owes \$13.25 to Ezekiel VARNEY, Cordwainer of Windham-notation shows 2nd Exon issued May 19, 1824.
36. Apr 23, 1824 – Israel HODGDON, Blacksmith of Windham, owes \$14.52 to George ANDERSON, Yeoman of Windham-notation shows 2nd Exon issued Jun 2, 1824.
37. Apr 23, 1824 – Jeremiah FIELDS, Yeoman of Windham, owes \$3.84 to Isaac PLUMMER, Gentleman of Windham.

38. Jul 11, 1824 – Henry MOORS, Yeoman of Bridgton, owes \$6.50 to Joshua DUNN, Sadler of Portland-notation shows 3rd Exon issued Jun 8, 1825.

39. Jul 11, 1824 – Jacob PATTANGALL, Yeoman of Windham, owes \$10.53 to Ebenezer PROCTER Jr., Trader of Windham. 3rd Exon issued Aug 14, 1824. 4th Exon issued Sep 23, 1824.

40. Jan 17, 1825 – Jethro LIBBY, Gentleman of Raymond, owes \$12.30 to John COLLINS, Trader of Windham. 4th Exon issued May 13, 1825-notation shows 5th Exon issued Aug 1, 1825. 6th Exon issued Dec 15, 1825-notation shows 7th Exon issued Apr 1826.

41. Apr 1, 1825 – Isaac BARTLETT, Yeoman of Raymond, owes \$4.72 to Joshua PERRY, Clothier of Raymond. Notation shows 4th Exon issued Aug 12, 1825.

42. Mar 8, 1826 – Isaac KILBORN, Gentleman of Windham, owes \$12.11 to George WILLIS, Merchant of Portland-notation shows 2nd Exon issued Mar 29, 1826.

43. Mar 17, 1826 – Solomon NASON, Yeoman of Windham, owes \$12.83 to Josiah CLEAVES, Wheelright of Saco, in the County of York, State of Maine. 2nd Exon issued Mar 29, 1826. 3rd Exon issued Aug 8, 1826.

44. Jun 27, 1826 – Daniel HODGKINS, Yeoman of Minot, owes \$19.19 to John EVELETH Esqr. of Windham.

45. Sep 11, 1826 – Increase BENNETT of Westbrook owes \$8.39 to Josiah BAKER, Yeoman of Windham-notation shows 2nd Exon issued Nov 22, 1826. 3rd Exon issued Apr 2, 1827-notation shows 4th Exon issued Aug 11, 1827.

46. Sep 13, 1826 – Edward ANDERSON, Yeoman of Standish, owes \$4.53 to Jonathan SMITH, Gentleman of Portland-notation shows 3rd Exon issued Sep 1, 1827.

47. Sep 13, 1826 – Edward ANDERSON, Yeoman of Standish, owes \$5.77 to Nicholas ANTHINE, Yeoman of Windham-notation shows 2nd Exon issued Sep 1, 1827.

48. Oct 18, 1826 – Hezekiah LOMBARD, Yeoman of Standish, owes \$4.47 to David HAWKS, Yeoman of Windham-notation shows 2nd Exon issued Nov 22, 1826.

49. Nov 4, 1826 – Isaac ELDER, Yeoman of Windham, owes \$6.26 to Joseph HAWKS, Yeoman of Windham-notation shows 2nd Exon issued Nov 9, 1826.

50. Jan 19, 1827 – Edward ANDERSON, Yeoman of Standish and William ANDERSON, Gentleman of Windham owe \$10.10 to David HAWKS, Yeoman of Windham.

51. Apr 6, 1827 – Thomas MORTON, Yeoman of Raymond, owes \$20.80 to Stephen MANCHESTER, Yeoman of Windham. 2nd Exon issued Jul 6, 1827-notation shows 3rd Exon issued Jan 8, 1828.

52. Oct 1, 1827 – Thomas MORTON, Yeoman of Raymond, owes Samuel ELDER, Yeoman of Gorham \$18.72-notation shows 2nd Exon issued Jan 4, 1828.

53. Oct 27, 1827 – Abraham MAYBERRY, Yeoman of Standish, owes \$1.77 to Elisha EMERY, Laborer of Gorham.

54. Sep 8, 1829 – Benjamin CRAGUE, Yeoman of Windham, owes \$7.10 to William MAYBERRY of Windham. Notation shows this is the 4th Exon issued for this debt.

54. Mar 10, 1833 – Jonathan LOWELL, Gentleman of Windham, owes \$17.36 to Thomas CONNEL, Yeoman of Gorham.

55. Nov 19, 1838 – Thomas SEALE Jr. and Jeremiah BAILEY, Yeomen of Westbrook, owe \$15.27 to John P. BABB, Yeoman of Windham.

56. Apr 18, 1839 – Jacob MANCHESTER, Yeoman of Windham, owes \$22.24 to John EVELETH Esqr. of Windham. 2nd Exon issued May 1, 1840.

57. Sep 1, 1842 – Naheum MANCHESTER, Yeoman of Windham, owes \$19.34 to M. HACKETT of Windham.

58. Sep 10, 1842 – Robert LOVEITT, Yeoman of Windham, owes \$16.97 to John EVELETH Esqr. of Windham. 2nd Exon issued May 31, 1844

59. Jan 13, 1843 – Leonard BAKER, Yeoman of Windham, owes \$10.66 to James CRAGUE, Yeoman of Windham. 2nd Exon issued Nov 23, 1843.

60. Apr 22, 1843 – John MEADE, Yeoman of Bridgton, owes \$8.48 to Moses HUNT, Yeoman of Windham.

61. Apr 22, 1843 – Jeremiah BARTON, Yeoman of Raymond, owes \$4.10 to John EVELETH Esqr. of Windham. 2nd Exon issued Nov 23, 1843. 3rd Exon issued May 31, 1844.

62. Apr 22, 1843 – Daniel H. EDWARDS, Yeoman of Otisfield, owes \$9.36 to Benjamin SOVEWELL (or LOVEWELL) Administrator of the goods and estate of Allen SCRIBNER, Yeoman late of Otisfield. 2nd Exon issued Nov 23, 1843. 3rd Exon issued May 31, 1844.

63. Apr 22, 1843 – Josiah LEAVITT and Dudley LEAVITT, Yeomen of Naples, owe \$20.52 to John EVELETH Esqr. of Windham. 2nd Exon issued Nov 23, 1843.

64. May 20, 1843 – Thomas EDES Jr., Yeoman of Otisfield, owes \$8.83 to John EVELETH Esqr. of Windham.

65. Aug 22, 1843 – David ROGERS, Yeoman of Casco, owes \$12.51 to William BAILEY, Yeoman of Windham.

66. Aug 22, 1843 – Daniel DAVIS, Yeoman of Naples, owes \$15.42 to John EVELETH Esqr. of Windham. Notation shows this is the 2nd Exon issued for this debt. 3rd Exon issued May 31, 1844.

67. Jan 24, 1844 – David ROGERS, Yeoman of Casco, owes \$12.51 to William BAILEY, Yeoman of Windham-notation shows this is the 2nd Exon issued for this debt.

68. May 31, 1844 – Ephraim WENTWORTH, Yeoman of Portland, owes \$13.12 to John EVELETH Esqr. of Windham-notation shows this is the 2nd Exon issued for this debt.

69. Undated – James M. BURRELL, Physician of Gorham, owes \$21.56 to Daniel SAWYER, Yeoman of Standish. [Note-bottom portion of this document which shows the date has been cut off].
