2. Apr 29, 1825 - William CONNELL, Yeoman of Gorham, owes \$18.82 to Samuel R. HAWKES, Trader of Windham. Court Costs \$3.06
3. May 6, 1825 – Joseph HASTY, Yeoman of Standish, owes \$20.00 to Samuel R. HAWKES, Trader Of Windham. Court Costs \$4.83
4. Jun 3, 1825 – Isaac KILBORN, Gentleman of Windham, owes 4000 “good Red Oak Steves”, reasonably worth \$6.00 a thousand to David VARNEY, Yeoman of Windham. Court Costs \$5.10
5. Jun 17, 1825 – Ebenezer H. ALLEN, Yeoman of Windham, owes \$19.53 with interest to Samuel R. HAWKES, Trader of Windham. Court Costs \$2.18
6. Jul 15, 1825 – Charles JOHNSON Esqr. of Windham, owes \$5.50 to Samuel R. HAWKES, Trader Of Windham. Court Costs \$2.18
7. Jul 29, 1825 – Elijah ALLEN, Yeoman of Windham, owes \$7.54 to John COLLINS, Yeoman of Windham. Court Costs \$2.30
8. Jul 29, 1825 – Henry MOORS, Yeoman of Otisfield, owes \$12.50 to John EVELETH Esqr. of Windham. Court Costs \$3.34
9. Aug 5, 1825 – Artemus TURNER, Yeoman of Otisfield, owes \$6.35 with interest to Samuel R. HAWKES, Trader of Windham. Court Costs \$3.34

16. Jan 9, 1826 – Thomas SAVAGE, Trader of Westbrook, owes \$61.50 to George W. LUNT, Yeoman of Westbrook and executor of the last will & testament of Daniel LUNT Esqr., late of Westbrook, deceased. Court Costs \$3.83 [see also, Oct 27, 1826 Summons]

17. Mar 31, 1826 – James HASKELL and Daniel HASKELL, Yeomen of Windham, owe \$8.42 with interest to Samuel NASON, Trader of Gorham. Court Costs \$3.70

18. Apr 28, 1826 – Zacheus ALLEN, Yeoman of Windham, owes \$8.68 to Asa SENTER, Yeoman of Windham. Court Costs \$2.18

19. Jul 7, 1826 – Aaron HANSCOM, Yeoman of Windham, owes \$13.25 with interest to Samuel R. HAWKES, Trader of Windham. Court Costs \$2.84

20. Oct 27, 1826 – Daniel LUNT, Gentleman, deceased, late of Westbrook, who's estate is in the Hands and under the administration of George W. LUNT, Executor of the last will and testament of Daniel LUNT owes \$20.00 to Thomas SAVAGE, Yeoman of Westbrook. Court Costs-defendant \$6.97, plaintiff \$4.28

21. Dec 15, 1826 – Benjamin GOOLD, Yeoman of Standish, owes \$2.01 to Israel CLEAVES, Wheelwright of Saco, in the County of York, State of Maine. Court Costs \$3.68 1825-1827 (con't)

22. Jun 15, 1827 – Isac PHINNEY, Yeoman of Raymond, owes \$14.38 to John EVELETH Esqr. of Windham. Court Costs \$3.07.

23. Sep 29, 1827 – Theophilus TOWLE, Yeoman of Windham, owes \$50.00 with interest to Abijah VARNEY, Yeoman of Windham. Court Costs \$2.32

24. Oct 19, 1827 – Elijah H. MORRELL, Yeoman of Windham, owes \$0.75 to Enoch CHESLEY, Yeoman of Windham. Court Costs \$2.28

25. Oct 19, 1827 – Thomas MANCHESTER, Yeoman of Windham, owes \$7.04 to Joseph LEGROW, Yeoman of Windham. Court Costs \$3.96
